The Glasgow School of Art's Archives and Collections actively safeguard, develop, document and preserve the institutional records of GSA and the artefacts and archives of staff, students, businesses and individuals associated with the School.

We do this to make the collection accessible in order to support scholarship and research, inspire creativity, and to surface hidden narratives contained within the School's history which are of relevance to contemporary academic and civic audiences.

Access to the collections is achieved both physically and digitally.

Physical Access:

The Archives and Collections' holdings are open to all visitors including the School's staff and students, external researchers, groups, families and members of the general public. You do not have to be affiliated with Glasgow School of Art to access our holdings, but please note, all children must be accompanied by an adult.

Archives and Collections (A&C) can be accessed via:

- Exhibitions and displays at <u>The Window on Heritage</u> visitor centre and Reid Gallery in the Glasgow School of Art's Reid Building.
- The Archives and Collections reading room at **The Whisky Bond**.

The Reid Building

Our temporary exhibitions and displays are shown in <u>The Window on Heritage visitor centre</u>, and in the <u>Reid Gallery</u>.

- Temporary exhibitions are advertised on the <u>Archives and Collections website</u>.
- No booking is required to attend exhibitions.
- There is level access to the exhibition spaces, as well as wheelchair accessible toilets.
- There is a small amount of chargeable on-street parking near the Reid building, but we would advise use of public transport where possible.



The Whisky Bond

- Our reading room is based at <u>The Whisky Bond</u>, and up-to-date opening times are published on the <u>Archives and Collections website</u>.
- We ask visitors to make an appointment in advance by <u>contacting the Archives and Collections</u>
 team on **0141 355 1418**, or by emailing <u>archives@gsa.ac.uk</u>. Please let staff know if you have any
 specific access requirements.
- Drop-in visits will be accommodated subject to availability.
- Our reading room facilities include disabled parking, lifts, disabled toilets and adjustable study desks to accommodate wheelchairs.
- Non-GSA visitors will need to register, and provide proof of identification, for instance a photographic record (passport or driving licence), a staff or student card, or some official documentation (a utility bill, a bank card or statement, a HMRC tax notification e.g. P45 or P60, a card or notification from DWP e.g. child allowance, pension, a council rent card or tenancy agreement or confirmation from an electoral register search).
- All visitors to the Archives and Collections must follow the **Reading Room Rules** which can be seen in the **Policies & Guides area of our website**.

Digital Access

Digital access to the collections is provided via a website, an online catalogue and through social media channels.

- Glasgow School of Art <u>Archives and Collections' online catalogue</u> provides a listing of our holdings, with contextual information and images where available.
- The <u>Archives and Collections' website</u> includes induction videos, curated content, browsable themed collections, how-to guides and help pages to aid access to the collection.
- <u>Twitter</u>, <u>Instagram</u> and <u>a blog</u> are used to highlight current activities, new collections and news-worthy stories.
- Our online resources meet <u>The Public Sector Bodies (Websites and Mobile Applications)</u>
 <u>Accessibility Regulations</u>. For more information, please check the <u>Accessibility statement</u> on our website.
- All information is conveyed clearly and accurately, using accessible language.

- Information is offered in alternative formats where possible and appropriate.
- Glasgow School of Art Archives and Collections content is also delivered through third party online portals such as the <u>Art UK website</u> and through the <u>Archives Hub</u>.

Please note

- As a result of the fire in the Mackintosh Building in May 2014 access to some areas of our holdings is limited.
- Access to some material may also be restricted for reasons of data protection or because of conservation considerations.
- Due to data protection legislation, access cannot be granted to un-catalogued records until they
 have been checked for personal data. Any requests for access to such material will be managed on
 a case-by-case basis taking into consideration the type and volume of records in question and the
 visitor's requirements.
- Most records which are over 30 years old are available for public consultation. Glasgow School of Art's institutional records which are less than 30 years old can be accessed with the permission of the Head of the relevant department of the School.
- There is restricted access to some student records until they are 75 years old in order to maintain personal confidentiality.
